## **Terms and Conditions**

- Our goal at Cara Mia Pet Resort is for your pet to receive the utmost respectable and extraordinary care that meets and exceeds your expectations.
- Aggression of any kind is not tolerated. We reserve the right not to admit your pet due to temperament issues.
- In order to protect the health of your pet and prevent the spread of disease or infection if your pets are showing symptoms of illness such as for example coughing, sneezing, vomiting, or diarrhea may not be permitted to attend or utilize our facility until they have a clean bill of health from your veterinarian.
- All pets must be picked up and dropped off either on a leash or in carrier. No exceptions. Crates may be brought in to help your pet with separation anxiety from home.
- All dogs are required to wear a collar that includes their identification tag.
- Verification of vaccinations or titers are required. No exceptions. For dogs: Rabies, DHPP & Bordatella. For cats; Rabies and FVRCP. Records may be faxed to (716) 568-2270
- Food and medications must be provided daily by the owner. Medication must be brought in the original prescription bottle along with instructions on how to administer.
- Although we do not co-mingle pets, females in heat must wear a diaper-pad cover up during their heat cycle. We can provide those at an additional charge.
- All pets must be on a flea and tick control year round. If your pet is found with fleas or ticks, the owner will be notified and the pet will be treated at the owner's expense. If not agreeable, then the pet must be picked up immediately.
- Should your pet become suddenly ill or a medical emergency arise we would contact you immediately, unless designated differently on your registration form
- Reservations are preferred to ensure your pet has its full pampering experience. Please call (716) 568-2272.
- Our Lobby hours are 6am – 10pm, but should you require special hours we are a phone call away to have arrangements made for you and your pet.
- Any harm or damage, or destruction caused by your pet while staying at or participating in services provided by Cara Mia will be deemed the owners financial responsibility. Such charges are due upon checkout unless other arrangements have been made
- Cara Mia will not release your pet if fees are not paid in full by the time of departure. Unless other arrangements have been made.
- As the owner of your pet you understand that Cara Mia LLC will exercise all due diligence and care in the guardianship of your pet. You hereby waive and release Cara Mia LLC, its employees, owners, and agents from any and all liability of any nature, for injury or damage, including that which may result from the actions of your pet. You expressly assume the risk of such damage or injury while your pet participates in or attends Cara Mia LLC while on the grounds or in the surrounding area thereto.
- In case of abandonment: 5 days after discharge date Cara Mia reserves the right to take ownership of the said pet. The owner will be liable for all boarding, food, shelter, medical attention, and legal fees associated with re-homing of the pet.
